# Jackson State University Notice of Proposed Sole Source Purchase SSP25-08 RFx 3150006083

Jackson State University anticipates purchasing the item listed below as a sole source purchase. Anyone objecting to this purchase shall follow the procedures outlined below.

#### **Product Overview:**

Flex VRA is the first and only visual reinforcement audiometry system that provides the audiologist complete control of the reinforcement stimulus. Utilizing a wide variety of video sources, Flex VRA is designed to be the most engaging and kid-friendly VRA system available. Audiologists can choose from cartoon, animal and toy (with or without animated lights) as well as their own user-uploaded VRA content.

## Explanation of need to be fulfilled by this item, how it is unique from all other options, and why it is the only one that can meet the specific needs of the department:

This is the first and only visual reinforcement audiometry system that provides the audiologist complete control of the reinforcement stimulus. We researched the product and determined that e3 Diagnostics is the only distributor of the product. We were unable to compare prices because the product is only distributed in the United States by e3 Diagnostics. However, we researched other commodities, but we didn't find any other commodities comparable to this one.

### Name of company selling the item and why that source is the only possible source that can provide:

e3 Diagnostics, 3333 N Kennicott Ave., Arlington Heights Illinois 60004 is the company selling this item. e3 Diagnostics (and all DBA's under e3 Diagnostics including e3 Med-Acoustics) is the sole source sales and service agent in the United States for the Flex Visual Reinforcement Audiometry System and accessories.

### Estimated cost of item and explanation of why the amount to be expended is considered reasonable:

This product has an estimated cost of \$7,775.00. The University was unable to compare prices because the product is only manufactured by one company, e3 Diagnostics (and all

DBA's under e3 Diagnostics including e3 Med-Acoustics). However, we researched other commodities, but we didn't find any other commodities comparable to this one.

### Explanation of the efforts taken by the department to determine that this is the only source and efforts used to obtain the best possible price:

- 1. With departmental need at front of mind, faculty researched the marketplace and found that this equipment is the only product available that will adequately meet the needs for the University's Department of Communicative Disorders.
- 2. Office of Purchasing and Travel searched DFA for item and vendor to no avail. Also searched web for alternate vendors to no avail as all listings of the product linked to e3 Diagnostics as the primary source/vendor for the Flex VRA system.
