Faculty and adjuncts were only counted once. Most faculty and adjuncts supervised at least one candidate during the fall semester and at least one candidate during the spring semester. Candidates are placed in partnering districts across the state but more specifically within 30 miles of the university, one way or 60 miles round trip. They are placed with highly qualified certified teachers with 3 or more years of experience. Candidates are not only mentored by the cooperating teacher but are assigned a university supervisor who observes and evaluates them four (4) times and formally evaluate them twice during the 480 hour clinical experience.

The College of Education and Human Development (COEHD) has forged strong partnerships with school districts throughout the state. COEHD is committed to the success of training prospective teachers through ensuring that all programs meet the required diversity standards and the needs of communities. This commitment is visible in our vision and mission goals of serving the Jackson metropolitan area. Commitment to diverse communities is a foundational commitment expressed in our conceptual framework as one of the unit’s goals. Unit and program curricula provide multiple opportunities for candidates to learn, practice, and demonstrate knowledge about diverse children, families, and communities and to utilize this knowledge effectively to help all students learn and develop. Our commitment is visible in our diverse body of candidates and the multiple opportunities they have to interact with each other in classes, field and clinical settings, and candidate organizations. Further, our commitment is demonstrated by the

diversity of the urban and metropolitan school districts and agencies that are utilized as a rich resource for field and clinical settings for all candidates. Through the integration of effective practice, candidates become aware of different learning styles and adapt instruction or services appropriately for all students, including linguistically and culturally diverse students and those with exceptionalities. Candidates are mentored by university supervisors and mentor teachers. The licensure programs require courses in areas such as special education, urban education and teaching in diverse environments. These courses are specifically designed to ensure candidates develop the practical knowledge, skills, and dispositions related to teaching in diverse environments. The Center for Teacher Quality tracks all field and clinical placements for initial teacher candidates to ensure they are placed in diverse settings across their program.

Candidates have access to computer labs and classrooms equipped with projectors, Mondo and smart boards, as well as, access to the University's state of the art multimedia center called "Innovate". Professional Development is provided to the students on the integration of technology in the classroom. Candidates have access to the Unit's Curriculum Center that is design to mimic the instructional resources available in most K-12 settings. Technology training is provided to the students through the center. Professional education faculty model the effective use of technology for instruction. All initial teacher education candidates take courses in the use of media for instruction and collecting/analyzing and are expected to be proficient in this area (ETEC 336 Utilization of Multimedia Skills and ETEC 367 - Assessment and Measurement) As part of their student teaching assessment, candidates are evaluated on their ability to impact learning through the use of technology and making data driven decisions, as appropriate to the content area. All candidates in initial and advanced programs are encouraged to take full advantage of technology available in their clinical and field experience sites. Throughout the program, candidates use technology to communicate with supervisors (e.g., electronic mail, Canva). Candidates engage in the use of technology to meet the needs of diverse learners and instructional enhancements (e.g., PowerPoint, web sites, video streaming, smart board, two-way audio/video). Candidates are taught to collect and analyze student assessment data using computer programs (e.g., Access, Excel, grade-book), and analyze student data. All teacher education candidates are required to enrolled in the SPED 311 course (Exceptional Children and Youth in the Schools). This course prepares students with the knowledge, skills and disposition to interact and teach diverse populations including students with disabilities. SPED 311 includes IDEA modules to ensure students can effectively engage in developing and participating in individualized education program meetings with in a school setting. SPED 311 has been redesigned to include Social and Emotional Learners (SEL) modules to assist in preparing teacher candidates to deal with student behaviors. Candidates demonstrate knowledge in content, pedagogical skills, student development, historical, theoretical, and learner environment management knowledge. Candidates integrate technology that enhances learning environments for all students to meeting their academic needs. Candidates participate in seminars and field-experience activities on campus and school sites to observe and have hands-on experiences in an exceptional education setting which include special education inclusion classroom.

Students are placed during field hours in diverse setting such as public schools and the schools for the deaf and blind students. Candidates are assessed through specific program assessments to determine their knowledge, skills and disposition to teach students with disabilities effectively such as a student learning module and the development of individualized learning plan. Specific courses have been redesigned to include Social and Emotional Learners (SEL) modules to assist in preparing teacher candidates to deal with student behaviors.
